

The annual General Meeting 2020-2021 of Mrinaljyoti Rehabilitation Centre was held on 20th November, 2021 at Mrinaljyoti Rehabilitation Centre, Kumudnagar, Duliajan under the Presidentship of Mrs. Bulbul Adhyapak, Executive President, MRC. The Secretary, MRC presented the Annual Activity and Financial Report and submitted the same to the President. The President and the house accepted the Annual Report unanimously.

Mrs.Sangeeta Borkakoty, President, Zaloni Ladies Club and other dignitaries from ladies club and inner wheel club, Duliajan graced the AGM as special guest.

The Gulab Rai Nihalani Scholarship (2020-2021) was awarded to Mr. Bitopan Gogoi for his commendable effort in the field of study.

It was registered that a total of 42 no's of delegates were present in the meeting.



3. Independent Projects

3.1: Schooling (Special &Inclusive)

Since its outbreak two years ago, the covid-19 pandemic has disrupted our education system. Like the others, the children With Disabilities who are completely dependent on their teachers were severely affected in their education and training in this crucial period. When it comes to children with disabilities, the situation is an additional challenge. The lack of access to education services and child development programs in centers due to the pandemic has been a source of agony to the children with special need and their families. Keeping in view of such situation we have introduced teaching, guidance through online mode. Which help a lot for continuing their academic advancement during this pandemic time.

Returning to normalcy after Covid-19, physical classes of Mrinaljyoti Rehabilitation Centre has begun as usual. The organization started regular classes for the children with Disabilities who have the ability, by adopting the State Syllabus. Students who are already in the age group of 14 and above and, have the capacity to continue their education; they were enrolled under the NIOS. At present the organization has Children with various Disabilities in its School set up. We are also continuing our special education unit for the profound and severe children who cannot be left out because they need continuous support. These children join the Inclusive set up students during the extra curriculum activities such as sports, yoga, dance, sign language class etc.







3.2: Early Intervention

Early intervention Centre ,is an actively running centre in the Mrinaljyoti campus for the children from age 0 to 10 yrs .Children having Cerebral palsy, autism, hearing Impaired, intellectual disability and multiple disability are having the therapy sessions. Due to Covid-19 outbreak from the year , 2020 May, we immediately started the online whatsapp group .Now at present there are total 60 participants.

From 2021-2022, the services imparted are home visits, field visits, dry ration distributions to the needy families. Around 20 nos. of children are receiving dry rations, medicines and other types of services every month.

Regular contact with the children through online modes, whatsapp group chats, webinars, parents meet is being continued .Field survey for those who could not come regularly are done and accordingly feedbacks are taken from the parents. Monthly Local Project committee meeting is held in the premises of Mrinaljyoti to discuss the overall activities of Disha project as well as the early intervention.

Parents training and sensitization programs are held to impart basic training and home based management to the parents.

Mainstreaming is an important aspect and primary objectives of the early intervention centre. Few of our children are able to get admitted in the regular school since 2017.





3.3: Skill Development Trainings (PUSHPADALUM)

Self employment is an important ingredient for combating poverty and achieving inclusion for all persons, including Persons with Disabilities(PwD). That is why we are continuing our skill development trainings for the Persons with Disabilities so that they can attain a dignified life like others in the society.

4. Unified Projects

4.1: Jyotiniwas (Home for Children with Disabilities)


As a part of our continuous services for the development of Persons with Disabilities, from the year 2012 we have been running a Child care Institute namely Jyotiniwas Children Home under the State Child Protection Society, Government of Assam.

The Children home provides care, protection and education to the Children in need of care and protection referred by the Child Welfare Committees (CWCs). Children with disabilities from incapacitate parents are also given hostel facilities here under CWC. To run this home for boys and girls financial support is being provided by the State Child Protection Society, Assam. There are 11 girls and 21 boys in the home.

4.2: Uttaran(Disha Project)

DISHA is an early intervention project which is currently being implemented by Mrinaljyoti Rehabilitation Centre under the National Trust, Ministry of Social Justice & Empowerment, Govt. of India

Since 2017, July Disha Scheme under National Trust is been implemented in the Early Intervention Centre of Mrinaljyoti Rehabilitation Centre. Main objective of this Disha Scheme is school readiness program i.e preparing the child for a regular school which is the primary door to the external world or the first step to the inclusive society. As per the scheme guidelines-Total batch capacity is 20 nos.

During the period 2020-2021 we provide Dry rations, Field visits, Home visits, counseling and home based management etc. to 20 nos. of beneficiaries. Moreover we provide medicines to those who are suffering from Epilepsy, fits etc.

Regular Local Project Committee (LPC) is held every month with 12 members. Parents training/Parents meet are organized to meet the feedbacks and overall development of the child.

Through Disha Scheme we are able to enroll few children to the regular schools. They are-

4.3: Project Parijat Phase 2

After successful completion of Project Parijat phase1, From March 2022 we have started the second phase of Project Parijat (A vocational Unit for differently abled) supported by Oil India Limited under Oil Sakshyam,FY2020-21. Under this project, specialized training has been provided on tailoring and embroidery for differently abled and regular persons.We have enrolled 7 numbers of specially abled persons and 3 numbers of normal persons for this training. Moreover we are continuing our supply of baby suits to the new born babies at Oil Hospital as per the requirement.

A NEURO-PSYCHIATRIC camp was organized in the premises of Mrinaljyoti Rehabilitation centre under Project "OIL SAKSHYAM" on 17.03.2022 .This camp was organized for the betterment of those children who have been suffering from long term seizures and those who have had behavioural issues. Prior to the neuro camp,the first phase of it i.e.the free Thyroid screening Camp was organized on 12.03.2022 in Mrinaljyoti itself. Many important tests had been done which were necessary for the evaluation of seizure. This is one of the objectives been taken in the local project committee under Disha Scheme . Consultant Neurologist,Mr.Rupam Hazarika,had attended the camp along with psychiatrist , Dr.Rupa Gohain. They talked about the probable causes of seizure, and its management. Psychiatrist, Dr.Rupa had discussed about the various behavioural issues like ADHD, lack of concentration ,temper tantrums etc and how to deal with it.

The camp was followed by the power point presentation presented by Dr.Rupam Hazarika. It has been an informative session interacting with the parents and guardians. He had let us know about the preventive measures and immediate handling of a child when the seizure starts. Immediately after the presentation, individual screening, evaluation and treatment of the children started. Around 45nos.of children were been screened and evaluated. Doctor had assured us a follow up and reviews of these cases very soon.
