FROM THE SECRETARY'S DESK



Since the beginning, Mrinaljyoti has been working with dedication to support and uplift children & Persons with special needs. Over the years, we have had the honour of reaching a large number of such children, Persons with Disabilities along with their families. Our efforts have helped us become a trusted part of the community - one that stands for Inclusion, care, and the belief that every Person & Child deserves a chance to grow and thrive. However, in my experience, there are still many challenges, especially in remote and rural areas. Many Persons with Disabilities & Children with Disabilities are unable to receive the support they need simply because their families don't have access to important medical records, like birth history. Without this, it becomes difficult to identify disabilities at an early stage. This delays the support the child needs and leaves families confused and unsure where to turn. As a result, many parents remain unaware of the disability services and rights available to them. It is painful to see children being left behind - not because of lack of potential, but because of lack of information and access.

This issue goes beyond individual families - it reflects a wider gap in our systems. Disability is not just about health; it is about equal opportunity, dignity, and inclusion. When a PwDs or a CwDs does not get the support they deserve, society as a whole is affected. Every person has the right to be seen, heard, and supported - regardless of where they live or what background they come from. To truly build an inclusive society, efforts from organizations like Mrinaljyoti are not enough. We need strong and ongoing support from government departments, better outreach in local communities, meaningful involvement of parents, and responsible media coverage. Schools, frontline health workers, local leaders, and civil society also play a crucial role. Inclusion is not the job of a few - it is the responsibility of all.

Each time I revisit our journey, I feel both proud and hopeful. Mrinaljyoti has grown stronger through the years, but what inspires me most is the spirit of people who continue to stand by our mission. Their belief reminds me that change is possible, and that every effort - big or small - matters. B. ACTIVITIES UNDER MRC

B.1. EDUCATION: -



B.1.1. SPECIAL EDUCATION

Since 1999, Mrinaljyoti Rehabilitation Centre (MRC) has been running the Special School Section, where education is provided to students who cannot be mainstreamed and require education in a special way. This setup mainly aims at providing a functional class, educating the child using different tools and technologies & preparing students for mainstreaming.

B.1. II. INCLUSIVE EDUCATION

In the year 2016 Inclusive setup was introduced. The School Section of Duliajan consists of classes from Nursery to Class VIII, NIOS, in which there are around 175 numbers of students. The numbers of students at Digboi Outreach Centre is 82 & at Rajgarh Outreach Centre is 38 nos. The UDISE Code is 18150610806.



B.2.III. CO-CORRICULUM ACTIVITES

At MRC, the holistic development of children remains a core focus. Daily yoga sessions are conducted to promote physical health and mental well-being. Alongside this, children actively participate in co-curricular activities such as art and craft, singing, and dancing, which fosters creativity, self-expression, and joy. These engagements contribute significantly to a nurturing and balanced environment for every child's overall growth.



DETECTION & THERAPEUTIC INTERVENTION: -

Under this unit : we have the following activities: -

B.2.I. PHYSIOTHERAPY:

MRC provides physiotherapy to intervene, assist and develop gross motor skills, fine motor and mobility of the children with special needs.



B.2. II. OCCUPATIONAL THERAPY (OT):

Through OT, we focus on improving sensory processing skills (understanding, registering, and responding to sensory information), fine motor skills (required for writing), and attention (by improving sitting tolerance) so that they are able to do basic things independently. It also helps them to participate in social situations independently and with confidence.



B.2.III. SPEECH THERAPY:

Speech therapy plays an important role in the holistic development of a child with special needs. By providing Speech Therapy, we try to improve overall communication, enhance social skills, and enable them to cope better with society and function in day-to-day life.



B.2. IV. COUNSELING:

Counseling is an inevitable part of the centre. It aims to provide a safe and supportive space for the parents as well as for the students to discuss feelings, worries, and fears, etc. Through counseling, we try to provide holistic techniques and process which help in the overall development of the beneficiaries.



C.PROJECT RUNNING UNDER MRC

C.I.PROJECT DISHA:

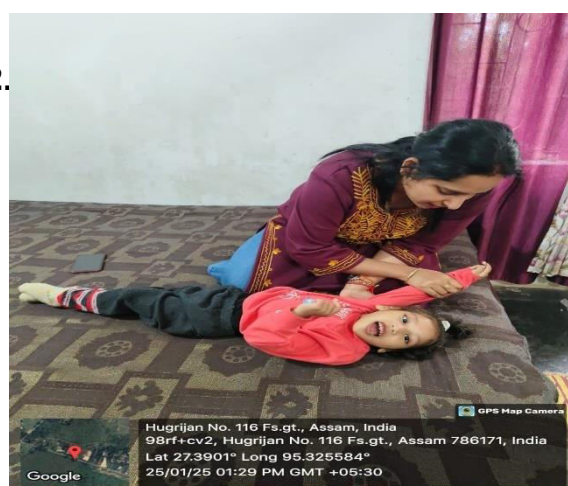
Project DISHA under the National Trust,(Ministry of Social Justice and empowerment,Govt.of India) aims for the development of children aged from 0 to 10 years by Early Identification and Early Intervention, to carry out these services, we have a Physiotherapist, Speech Therapist, Occupational Therapist, Special Educator, Counselor, Guest Neuro- development Therapist and Trained Teachers.

DISHA ACTIVITY REPORT (ACADEMIC SESSION: 2024-2025)

- 1. HOME VISITS:** As a regular activity of Disha, we conduct home visits for students who are irregular due to various reasons, such as health issues, poor transportation facilities, or extreme weather conditions. Follow-up and counseling sessions is an integral part of the home visit In the year 2024-2025, a total of 66 home visits were conducted in the areas of Duliajan, Naholia, Naharkatia, Bordubi, Tengakhat, etc.

2. **LPC MEETING:** The Local project committee is constituted under the Disha scheme with a total of 12 members. The LPC meeting is held monthly basis in the Early Intervention Unit to discuss the activities carried on, in the unit for the development of the children.

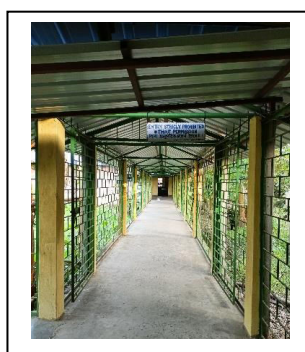

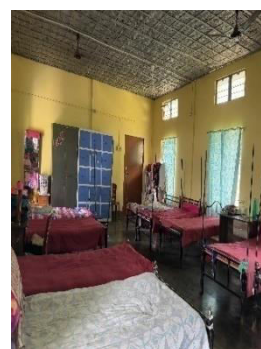

At present, there are 31 children to whom shelter, care, protection, education, etc, are provided. The Home is running under the State Child Protection Society, Assam (SCPS).

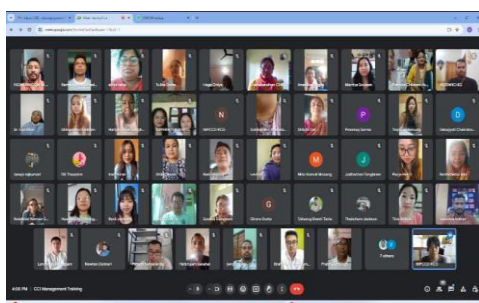

CIII. PROJECT OIL SAKSHYAM

Under the aegis of Oil India Limited's CSR intervention project OIL SAKSHYAM, this year, we continued our dedicated efforts, focusing on holistic development and empowerment of Persons with Disabilities (PwDs). As per the agreed terms outlined in the Memorandum of Understanding (MoU) between OIL and MRC dated 31st March, 2023, this second year was marked by impactful community-based awareness programs, comprehensive training sessions for ASHA and ANGANWADI workers, parents' training programs and the fitment of assistive devices following an extensive assessment camp. Additionally, our various vocational training programs and placement-oriented skill development initiatives have paved new pathways for self-reliance and economic empowerment among PwDs and economically weaker sections. Each of these initiatives was carefully planned and executed based on the insights derived from a detailed field survey conducted by our dedicated team.

Following activities were conducted under Project OIL SAKSHYAM in the FY 2024-25.

1. FIELD SURVEY PROGRAMS:

In alignment with our mission to reach the most vulnerable, we carried out extensive field surveys across remote areas of Dibrugarh and Tinsukia districts. The surveys focused on identifying critical gaps in documentation, healthcare access, awareness on disability rights, educational inclusion, and livelihood opportunities. This initiative revealed numerous individuals with disabilities lacking documentation, healthcare access, and essential services etc. These findings formed the foundation for strategic program interventions and targeted outreach programs



2. Community-Based Awareness Programs:

Responding to survey insights, we organized four intensive community-based awareness programs in remote locations, prioritizing villages with the highest concentration of undocumented and underserved PwDs. These sessions provided crucial information on rights, entitlements, government schemes, and available services—bridging the information gap for many marginalized families.

3. Awareness cum training program for Asha and Anganwadi workers

To strengthen early identification and timely intervention, we conducted three impactful awareness sessions with ASHA and Anganwadi workers in various locations of Dibrugarh and Tinsukia Districts. These programs aimed to bridge the gap in knowledge about disabilities and to address the critical issues faced by individuals with disabilities in these underserved regions. The programs were designed to empower grassroots workers with the tools and knowledge needed to identify, referral pathways, support, and facilitate services for persons with disabilities (PwDs).

4. Parents Training Program

Understanding the pivotal role of families in the development of children with disabilities, we successfully conducted three parents' training sessions during the year. These covered a broad spectrum of topics including health and hygiene, legal rights, home-based care, food and nutrition, and psychosocial support. The primary goal of the training programs was to empower parents of children with disabilities by providing them with knowledge and skills to improve the overall quality and as well as their children's life.

5. Assessment and fitment of orthotic devices

In collaboration with Mobility India, we hosted a three-day orthotic assessment camp, followed by a three-day fitment program. This initiative addressed the mobility and rehabilitation needs of individuals with physical impairments, ensuring the delivery of customized orthotic devices and professional guidance for improved mobility and quality of life.

6. MOTHERS' TRAINING PROGRAM

Recognizing mothers as primary caregivers, we organized three dedicated training programs aimed at equipping them with specialized knowledge and hands-on skills to support the developmental needs of their children with disabilities. The sessions emphasized practical caregiving, early stimulation, emotional support, and inclusive nurturing practices.

The training sessions were conducted at three carefully selected locations, ensuring accessibility for families from diverse regions. These locations were identified based on the field survey data, prioritizing areas with the highest need.

Program 2: As part of the 'SWACCHATA HI SEVA' campaign 2024 sponsored by the OIL INDIA LIMITED (OIL), a special cleanliness drive was conducted by the MRINALJYOTI REHABILITATION CENTRE (MRC) at Tipling Tea Estate Anganwadi Center on 19th September, 2024. The event emphasized the importance of maintaining a plastic-free environment by displaying practical example of natural handmade products crafted by PwDs of MRC as a substitute to plastic and also

urging attendees to adopt such sustainable practices for a healthier society. As a part of this initiative Water Hyacinth dustbins crafted by PwDs of MRC under CSR project 'OIL SAKSHYAM' were distributed to various nearby Anganwadi centers, health centers, schools and TE etc. thereby enabling their socio-economic empowerment and also promoting eco-friendly products as substitutes for plastic



ACHIEVEMENT

A significant number of undocumented individuals with disabilities identified by team MRC during various awareness and field survey Program under Project 'OIL SAKSHYAM' attended the disability certificate screening camp held on 3rd May, 2024 at Asha Griha, Tinsukia. The camp was meticulously organized and executed by the District Administration of Tinsukia under "MISSION THOUGHTFUL". Our field survey program, community awareness campaigns, and training programs for ASHA and Anganwadi workers, as well as parents, played a pivotal role in identifying and supporting such individuals.

This disability certificate screening camp was a significant milestone in the second year of our MoU activities. This achievement was made possible through the synergistic efforts of our team MRC, the district administration, and the invaluable support of our funding partner OIL. The camp not only empowered individuals with disabilities but also strengthened the foundation for an inclusive society.

Along with these activities, as part of our continuous commitment towards empowering Persons with Disabilities (PwDs), their families, and economically disadvantaged communities, we undertook a series of impactful vocational training initiatives during the year 2024–25 under the CSR Intervention Project OIL SAKSHAM of our esteemed funding partner Oil India Limited. These activities were strategically implemented through our Vocational learning Centre Pushpdalum, which aimed at strengthening and upgrading the existing vocational and commercial activities of the Pushpdalum Centre. The core objective of these interventions was to equip PwDs, their family members, and individuals from Below Poverty Line (BPL) backgrounds with practical skills to enhance their livelihood opportunities and promote economic independence. The following key training categories were successfully implemented:

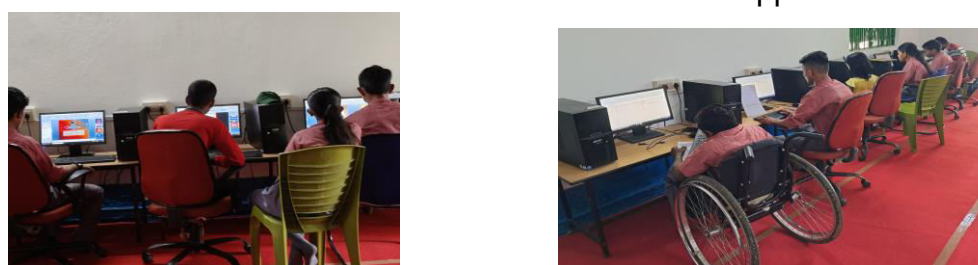
1. TRAINING ON PERSONALITY DEVELOPMENT, SKILL AND CAPACITY BUILDING

In this second year of the MoU, three batches of beneficiaries completed the training session on Personality Development and Skill and Capacity building organized in collaboration with Youth 4 Job Foundation in Guwahati and supported by Oil India Limited(OIL) under its CSR intervention project 'OIL SAKSHYAM'. This program was specifically designed to enhance the employability of persons with disabilities (PwDs) through comprehensive skill training and personality development. A total of 7 individuals with disabilities (3 batches) individuals with disabilities actively engaged in the training sessions, and 3 of them successfully secured employment in reputable organizations, marking a significant milestone in their career journeys.



2. ADVANCED COMPUTER COURSES FOR LIVELIHOOD GENERATION

Building upon the success of the first-year Computer Basics Certificate Course, this year we initiated advanced computer training programs in Desktop Publishing (DTP), Photoshop design, printing, editing, and other income-generating services related to the printing press, etc. This initiative aims to empower Persons with Disabilities (PwDs) with market-relevant skills for sustainable livelihood opportunities.

3 .TRAINING ON FOOD PROCESSING:

This initiative aimed to empower participants with practical skills in the preparation of various food items, enabling them to start micro-enterprises or take up self-employment. Three batches of training were conducted on cake baking, pickles, sweets, snacks, and other processed food products. Participants also received guidance on hygiene, packaging, and local market linkages, equipping them to independently generate income from home-based food ventures. The program was especially impactful for women caregivers and mothers of children with disabilities, offering them a sustainable avenue for income generation.



4. TRAINING ON ART AND CRAFT:

In this year we have conducted three batches of training on various art and craft techniques. This initiative aimed to empower Persons with Disabilities (PwDs), their families, and economically weaker sections of society by equipping them with skills to generate sustainable livelihoods. Participants were trained in crafting day-to-day utility items, decorative products, and gift items using eco-friendly and locally available materials. The training emphasized both traditional techniques and innovative designs to ensure the products meet current market demands.



5. TRAINING ON TAILORING (CUTTING, KNITTING, EMBROIDERY ETC.)

As part of our ongoing commitment to empower individuals with disabilities and economically weaker sections, this year we have successfully completed two batches of training on tailoring, cutting, embroidery, and stitching, etc. Building upon the foundation established in the first year, this initiative has continued to yield transformative outcomes for the participants and their families. The two batches, each spanning a comprehensive training period of 6 months, were designed to equip participants(5 in each batch) with hands-on skills in tailoring and dressmaking.



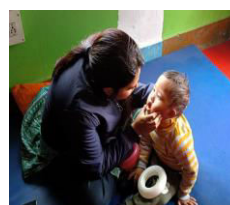
6. TRAINING ON HANDLOOM WEAVING

This year, we completed two batches of training on weaving handloom-based products such as gamusas, stoles, and other items. This was the first time we introduced training on weaving by using handloom jacquard machines, transitioning from the earlier use of traditional matixal techniques. This upgrade marked a significant milestone in enhancing the skills of participants and improving the quality and variety of products



DAY –TO-DAY REGULAR ACTIVITIES UNDERTAKEN

As a organization dedicated to empowering Persons with disabilities(PwDs),we have been continuing a range of daily activities and services that have become the backbone of our operations. The continued help and support of OIL to our cause has played a pivotal role in the successful execution of several key initiatives aimed at improving the wellbeing of persons with disabilities. We have been able to implement therapeutic interventions, special education, and schooling activities without interruption. These initiatives have greatly benefited the individuals we serve, enabling them to lead more fulfilling lives and participate actively in their communities. These activities are made possible through the funding support we received, particularly for specialized staff payment, administrative expenses etc. This support has been crucial in allowing us to continue our work and reach even more *individuals in need*.



C IV. PROJECT INDIAN OIL MRINALJYOTI REHABILITATION CENTRE (IOMRC)

Under the framework of the ongoing partnership between Mrinaljyoti Rehabilitation Centre and the Indian Oil Corporation Limited (IOCL), the financial year 2024–25 witnessed several impactful interventions and service implementations as per the agreed terms of the Memorandum of Understanding dated 12th January, 2024. We are pleased to report the following highlights of the year:

1. PROCUREMENT AND INSTALLATION OF THERAPY EQUIPMENTS

In alignment with the approved project plan, we successfully procured and installed all required therapy equipment and accessories. These include essential tools and instruments for physiotherapy, speech therapy, occupational therapy, and special education. The upgraded therapeutic infrastructure has greatly enhanced our capacity to deliver consistent, high-quality services to beneficiaries.



2. THERAPEUTIC SERVICES FOR PERSONS WITH DISABILITIES

We provided a comprehensive suite of therapeutic interventions—including physiotherapy, speech therapy, occupational therapy, and special education—to 25 enrolled persons with disabilities, as sanctioned under the project Indian Oil Mrinaljyoti Rehabilitation Centre(IOMRC). In addition to these, we extended these vital services to other beneficiaries beyond the initially sanctioned count, thereby maximizing outreach and impact. The regular therapeutic sessions have contributed significantly to the functional and developmental progress of children and individuals with various disabilities.



3. DISTRIBUTION OF NUTRITIONAL SUPPORT AND TRAVEL ALLOWANCE

As part of our holistic support strategy, nutritional ration kits were distributed every month to the 25 primary beneficiaries as per the project term. In parallel, traveling allowances were directly transferred to their respective accounts, ensuring smooth access to therapy and other institutional services. These initiatives have not only supported the physical well-being of the beneficiaries but also helped ease the financial burden on their families.



4. COUNSELING, SPORTS & RECREATIONAL ACTIVITIES

Recognizing the psychosocial aspects of disability, our team organized regular counseling sessions for both parents and children. In addition, vocational, sports and recreational activities were conducted periodically, encouraging physical movement, social engagement, and confidence building among the children. These interactive sessions were met with great enthusiasm and have had a visible positive impact on the children's morale and developmental progress.



5. Special Visit by IOCL Officials on Refinery Day

A moment of great honor and encouragement for our organisation came on 11th December, when a team of distinguished officials from IOCL, led by the Honourable Executive Director(rtd.)Mr. Ajay Kaila, visited our center as part of Refinery Day celebrations. During this memorable visit, the dignitaries interacted with our children and staff, reviewed the project progress, and kindly distributed various useful accessories to our disabled students. Their gracious presence and generous gesture was deeply motivating for our entire team and beneficiaries.



We sincerely express our heartfelt gratitude to IOCL and its leadership for their unwavering commitment, timely support, and collaborative spirit throughout the project period. Their consistent encouragement has enabled us to continue our mission of empowering persons with disabilities through structured support, dignity, and inclusion.

We look forward to carrying this partnership further with the same dedication and mutual goal of building a more inclusive and compassionate society.

C.V. PROJECT INCLUSIVE DEVELOPMENT FOR CHILDREN AND YOUNGSTERS WITH DISABILITIES. (IDCYD)

Mrinaljyoti Rehabilitation Centre has been running a project called Inclusive Development for Children and Youngsters with Disabilities (IDCYD) since 2021 at Rajgarh Out reach Centre. The project is being implemented under the Jan Vikas Samiti of Uttar Pradesh in collaboration with Mrinaljyoti. In 2024, we accomplished a great deal of work. The work is detailed below.

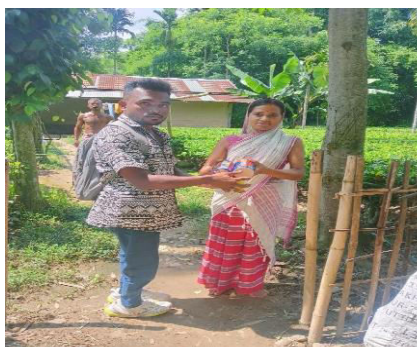

Note - 1 Brief about the entity

Mrinaljyoti Rehabilitation Centre ('Society') is a registered society under Societies Registration Act, 1860 located at Kumud Nagar, Duliajan, Dibrugarh - 786602. The Society is also registered under Section 12A and 80G of Income Tax Act, 1961. The objectives of the Society are mentioned in Para 5 of the updated Memorandum of Association.

Note - 2 Significant Accounting Policies

i) Basis of Accounting

a) The financial statements have been prepared under the historical cost convention system and in accordance with the generally accepted accounting principles prescribed in the framework for the preparation and presentation of financial statements and Accounting Standards issued by Institute of Chartered Accountants of India.

b) The Society generally follows mercantile system of accounting and recognises significant items of income and expenditure on accrual basis.

ii) Revenue Recognition

Revenue items are recognised on their accrual. Donations are recognized on receipt basis, unless there is reasonable certainty of collection.

iii) Property, Plant & Equipment

The gross carrying amount has been determined on the basis of cost model. Cost includes all expenses incurred to bring the asset to its intended use. Depreciation is charged on a written down value at the rates specified under the Income Tax Act 1961.

Properties under construction are stated at cost less accumulated impairment losses if any, until construction or development is completed at which time they are reclassified to be accounted for as an item of Property, Plant & Equipment. Cost capitalised includes cost of land and other directly related development expenditure, including borrowing costs incurred in developing the asset.

iv) Government Grants

Government Grants related to income are recognised in the statement of profit and loss on a systematic basis over the periods in which the Company recognises as expenses the related costs for which the grants are intended to compensate. Grants receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Company with no future related costs are recognised in the statement of profit and loss in the period in which they become receivable. Grants related to acquisition of Property, Plant & Equipment has been adjusted against the cost of the asset.

v) Investments

Investments, that are by their nature are readily realizable and which the management intends not to hold these for more than twelve months (from date of purchase) are classified as current investments. All other investments, both equity and non-equity investments, even if these are freely marketable, are classified as non-current.

vi) Provision for Current Tax

The Society is licensed to pursue charitable objects and is registered under sub clause (i) of clause (ac) of sub section (1) of section 12A of Income Tax Act, 1961 and as such income is not taxable in view of exemption under Section 11 and 12 of Income Tax Act, 1961.



vii) Accounting standards

The accounts as at 31st March 2025 have been prepared in compliance with the Accounting Standards prescribed by the Institute of Chartered Accountants of India (ICAI).

viii) Previous years figures have been regrouped/rearranged wherever considered necessary to conform to the current year's classification.

ix) The Society is a Micro, Small and Medium size=entities (MSMEs) as classified by ICAI falling under Level IV entities. Accordingly, the financial statements have been prepared and presented using the relaxations/exemptions available to Level IV entities.
